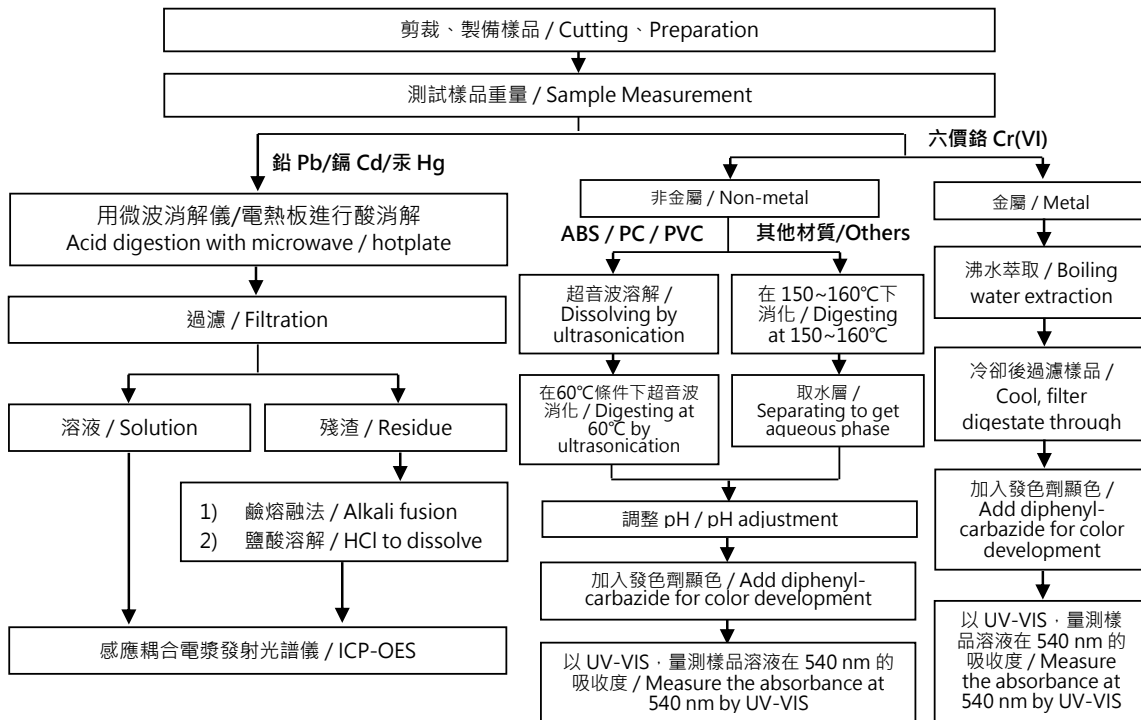

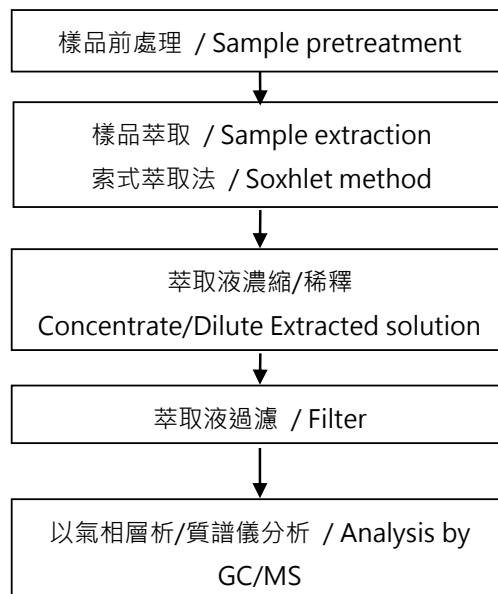

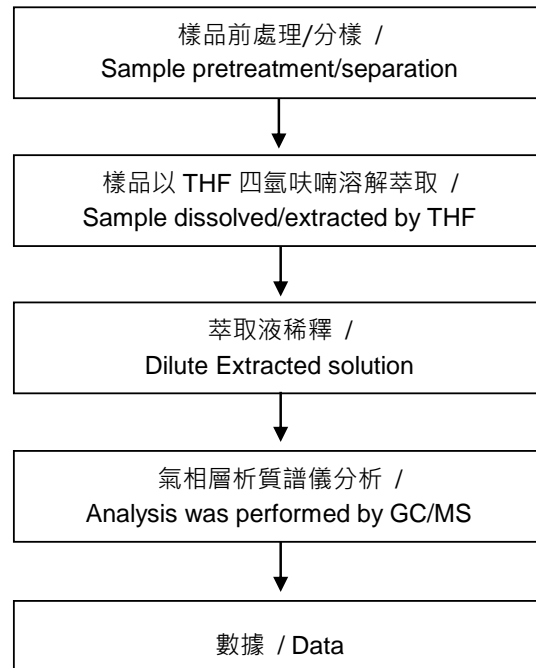

### 可塑劑分析流程圖 / Analytical flow chart of phthalate content

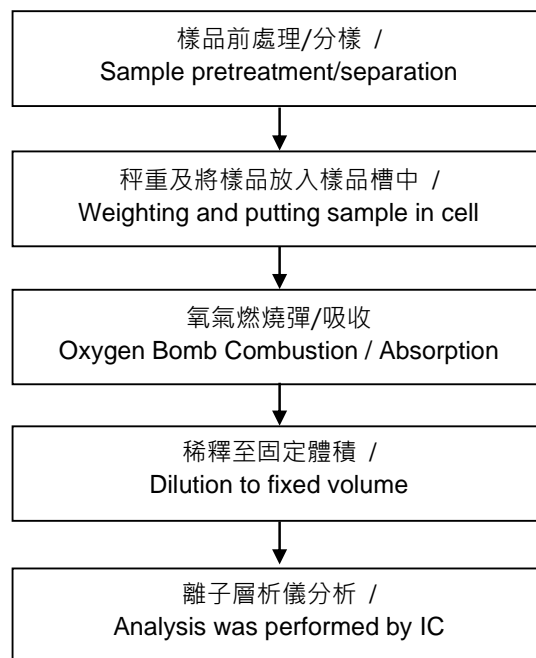

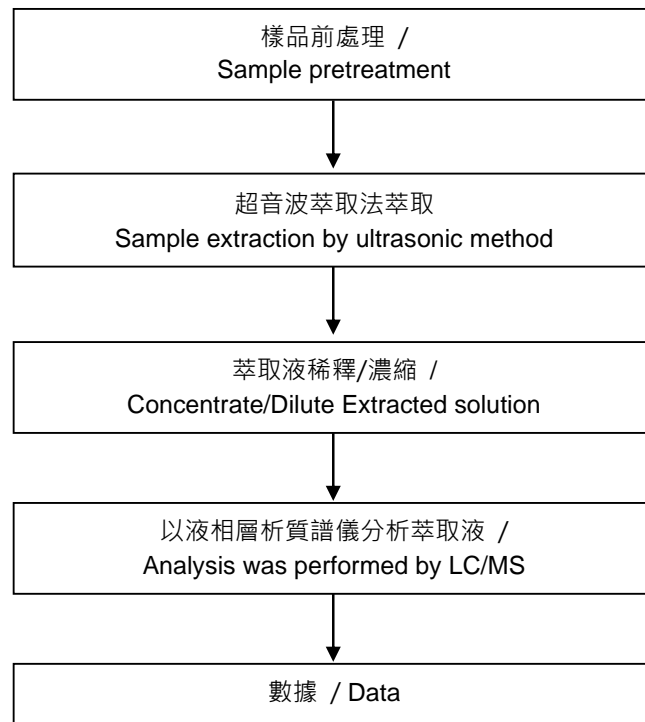

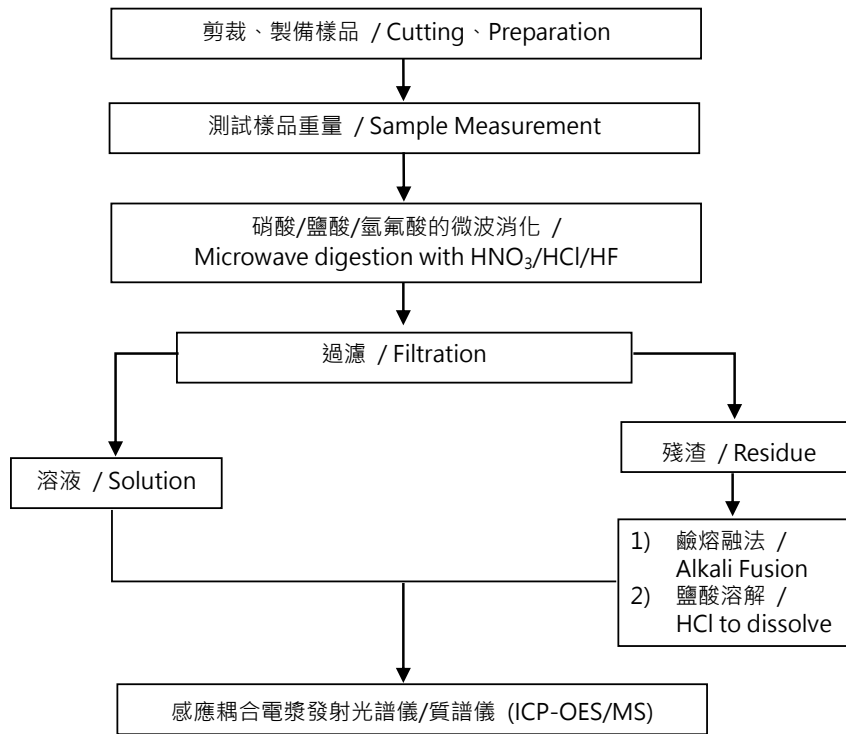

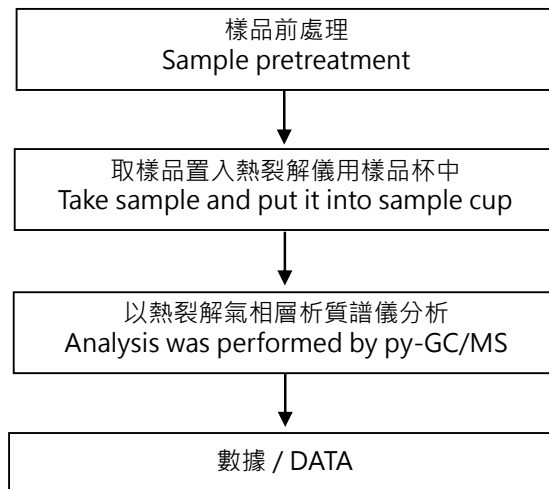
